### EXHIBITOR AGREEMENT

#### 13th International Working Conference on Stored Product Protection (IWCSPP 2026)

#### This Agreement is made between:

The Local Organizing Committee (LOC) of IWCSPP 2026 ("Organizer")

and

#### 1. Definitions

1.1 "Conference" means IWCSPP 2026 occurring October 19-23, 2026 at Speke Resort Munyonyo, Kampala.

1.2 "Exhibition Space" refers to the allocated area specified in Section 3.

#### 2. Contract Formation

2.1 This Agreement becomes binding upon:

- Receipt of completed registration form
- Payment of 100% full fees

#### 3. Exhibition Space

3.1 LOC grants Exhibitor non-exclusive use of [Booth Number/Size] in the [Location] hall.

3.2 Space allocation is at LOC's sole discretion, prioritizing by:

- Sponsorship level
- Registration date
- Technical requirements

#### 4. Fees & Payment

4.1 Total Fee: USD [Amount]

4.2 Includes only space rental - booth construction/services contracted separately with Official Provider.

#### 5. Exhibitor Obligations

5.1 Must:

- Contract with Official Exhibition Service Provider for all booth needs
- Comply with venue safety regulations
- Maintain insurance (minimum \$1M public liability)

5.2 Prohibited:

- Subletting space
- Obstructing aisles
- Selling outside approved products



## **6. LOC Obligations**

### **6.1 Will provide:**

- Basic power/Wi-Fi
- General security
- Listing in conference materials

## **7. Cancellation**

### **7.1 Exhibitor cancellations:**

- >90 days prior: 50% refund
- <90 days: No refund

### **7.2 LOC may cancel with full refund if Conference is postponed.**

## **8. Liability**

### **8.1 LOC is not responsible for:**

- Loss/theft of exhibitor property
- Service Provider failures
- Attendee injury from exhibitor activities

## **9. Intellectual Property**

### **9.1 Exhibitor warrants they have rights to all displayed materials.**

### **9.2 LOC may use exhibitor names/logos for promotional purposes.**
